Item No.1: Presentation of the Suganya R titled “Evaluation of antiulcerogenic effect of *Phyllanthus emblicain* male Wistar rats: An experimental study.”

Item No.2: Presentation of the G R Polillan titled “Evaluation of anti-convulsant activity of methanolic extract of seeds of *cassia fistula* against pentylenetetrazole induced convulsion in male Swiss Albino mice: An experimental study.”

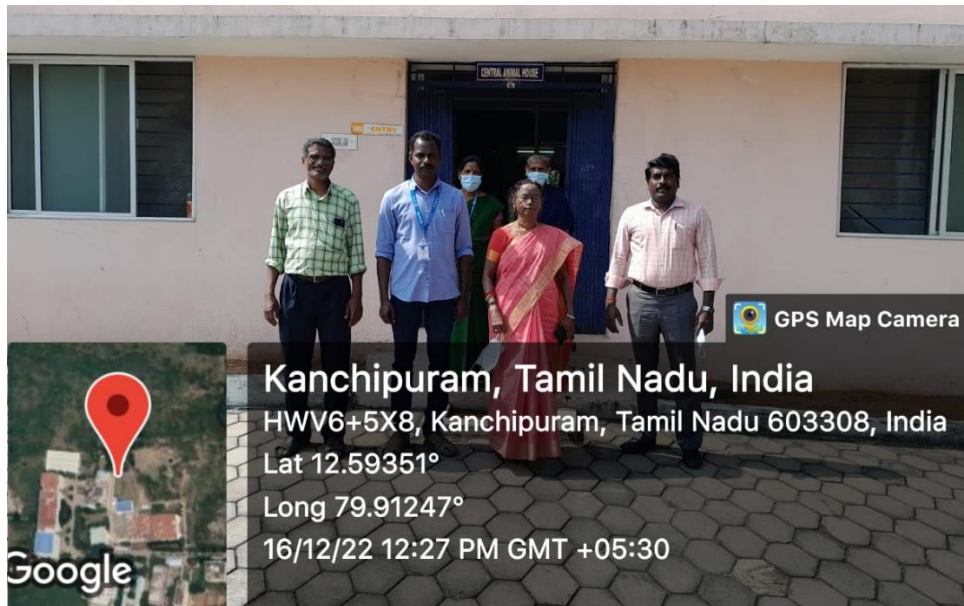
