Agreement

This Agreement is made and executed on day of 22/06/2022 at Hyderabad, by and between: **DocTutorials Edutech Private Limited**, a company incorporated under the provisions of Companies Act, 2013) and having its Head office at JIVI Towers, Road No-7, Banjara Hills, Hyderabad – 500034 through its authorized Director **Dr. Adit Desai** (hereinafter referred to as "DocTutorials" which term shall where the context so admits include their legal heirs, assignees, executors, successors, legal representatives and administrators) of the one part.

AND

Karpaga Vinayaga Institute Of Medical Sciences And Research Center represented by Principal Dr Sufala Sunil Vishwasrao the college herein after referred to as "College" which term shall where the context so admits include their legal heirs, assignees, executors, successors, legal representatives, and administrators) of the other part.

That the DocTutorials to this agreement is in business of recording/distribution of educational content for doctors and medical students through digital platform.

Now, both need to enter into this agreement on the following terms and conditions: -


1. DocTutorials will install android tablets with unlimited access to all Post Graduate preparation packages created by the 'DocTutorials' in the library premises of the college. The no. of tablets to be installed will be 2.
2. DocTutorials will install charging station in college library to hold these Android tablets.
3. DocTutorials will provide 2 sets of notes (containing 19 books per set) to the Second Party.
4. The College will provide the acknowledgement for the Tabs, working stations and books etc. placed by the DocTutorials.
5. That DocTutorials will be responsible to update the notes and tabs/digital content each year and make sure the latest edition is available in the college library
6. That DocTutorials will give free access of PG preparation packages to 2 topper students per MBBS batch of the college. These students will be recommended to DocTutorials by the Dean of the college.
7. That the Second Party will be responsible for the safety of devices installed.
8. That the Second Party cannot have a similar contract or agreement or MOU with any other who is a direct or indirect competitor of DocTutorials.






9. That the second party will have to bear the cost (Rs.10000/- Tab or charging station) in any tab / Charging stations etc. damaged or lost.
10. Term & termination: That this agreement is valid for a period of one year from the date entering into this agreement, valid up to 21/06/2023. Upon expiry of agreement both parties will mutually decide future terms and conditions, which will be the subject matter of the new agreement.
11. Upon termination of this agreement the second party, i.e., college will return all the material (Tabs, charging stations, books etc.) placed by DocTutorials in working condition. Either party must give 3 months' notice period while terminating the agreement.
12. That any dispute(s), arises out of this agreement, which may arise any time during the period of this agreement, shall be referred to Arbitration and such an arbitration shall be governed by the provisions of "Arbitration and Conciliation Act 1996 in Chennai Jurisdiction only. The arbitrator will be appointed with both parties at mutual consent.
13. That Both the parties have entered into present agreement with their own free will, consent, wishes and without any pressure or coercion from any quarter whatsoever on either side.
14. That both the parties to this agreement had agreed and undertake they will remain bound by the terms and conditions of this agreement and further undertake that they will not violate any terms and conditions of this agreement.
